# **Competition Information**

#### **Dates**

September 24 - 26, 2021

#### Venue

The competition venue is in Sports hall Verde Oktoih 2, Donja Gorica Podgorica, 81000. Compatition will be held on **four tatamis**.

Meetings, registration and weighins, will be held at the Voco Hotel. The hotel and the sports hall are located in the same complex.







#### **Athletes**

The tournament is open to all SSEKF members. All members of the national teams can participate (holding a passport/ID, residence card or membership of the national team).

Participants cannot be member of any other national team. The national federation will guarantee the membership accordingly. (Checks will be done through Sportdata by the executive committee.)

# **Registration Process**

Entries must be submitted on the Sportdata website, www.sportdata.org. Deadline is 10th of September 2021. No registration or substitution is possible after this date.

## **Competition Rules**

The competition will be ruled by 2021 WKF-SSEKF rules, for all categories.

# **Program and Draws**

Details of the competition program will be made available after all delegations' registration has been concluded.

The draw will take place 1 day before the tournament via the Sportdata system.

At the championships, the finalists of all events of the previous year will be separated in different pools.

Each team will be provided with two (2) sets of printed draws. If you need additional draws, you must print them out yourself.

# Liability

Each competitor must have their own medical insurance. The organizer does not accept any form of liability whatsoever.

# **Eligibility**

# **Participating Athletes**

In each category, 4 athletes per nation are eligible to compete. In team competition, each nation may enter up to 4 teams per category. The athletes must compete for the country they were registered by.

Athletes are permitted to compete once each in individual kata, individual kumite, team kata and team kumite (one team in each discipline). Moreover, junior athletes can register in senior individual kata based on the WKF rule for 16+ years of age.

For team kata there will be a category for 12-15 years old and another for 16+ over years old.

Athletes' age category will be determined by their age on the first day of competition, September 24th.

Each competitor must have their own medical insurance. The organizer does not accept any form of liability whatsoever.

#### Referees

Every country is obliged to provide at least three (3) referees.

Referees with a valid WKF/EKF license are welcomed. National referees must take the SSEKF licence examinations in both kata and kumite, which are based on the WKF exams. The referee course and accreditation process will be communicated to the national federations.

#### Coaches

Only persons with a valid, official SSEKF coach accreditation card are allowed to enter the competition area. Other persons are not allowed in the competition area. Official dress code is a track suit. The coach card is to be worn visibly.

# **Categories**

#### **Individual Kata**

- Male / Female U14 years (12-13 years)
- Male / Female Cadet (14-15 years)
- Male / Female Junior (16-17 years)
- Male / Female U21 (18-21 years)
- Male / Female Senior (16+ years)

#### **Team Kata**

Each team must consist of 3 competitors.

- Male / Female U16 (12-16 years)
- Male / Female Senior (16+ years \*)

#### **Individual Kumite**

If fewer than 3 competitors are registered in a category, the competitors will automatically be reallocated to the next higher weight category. If fewer than 3 competitors are registered in the highest category, they will automatically be reallocated to the next lower category.

In Kumite modality and in any weight if there are less than four competitors the organization reserves the right to pass the category/ies to OPEN.

All categories will have teams of 3 athletes. Each team may include an alternate athlete, for a total of 4 registered team members. It will be possible to compete with only 2 competitors.

# **Montenegro**

## **About Montenegro**

Montenegro (Montenegrin: Crna Gora), is located in South-eastern Europe. It has a coast on the Adriatic Sea to the south-west and is bordered by Croatia to the west, Bosnia and Herzegovina to the northwest, Serbia to the northeast, and Albania to the southeast. Its capital and largest city is Podgorica, while Cetinje is designated as the Prijestonica, meaning the former Royal Capital City.

The country got its name (literally, "black mountain") from the dark, mountain forests that cover the land. Some 60 percent of the country is more than 1,000m high, with the tallest peak Bobotov Kuk (Durmitor) reaching to 2,522m.

The coast of Montenegro is 294km long. A notable feature of the Montenegrin coast is Bay of Kotor, a fjord-like gulf, which is in fact a submerged river canyon. The Bay of Kotor is surrounded by mountains up to 1,000m high, which plunge almost vertically into the sea.

#### **Natural Beauty**

Back in 19th century, Lord Byron wrote "At the birth of our planet, the most beautiful encounter between the land and the sea must have happened at the coast of Montenegro. When the pearls of nature were sown, handfuls of them were cast on this soil." Montenegro still retains its natural charm and beauty. Architecture dating back to the 12th Century is still prevalent among the many UNESCO heritage towns and villages. Montenegro's natural beauty is dramatic; mountains dropping down to mirrored water in the UNESCO heritage Kotor bay and the crystal clear waters of the Adriatic lapping the sandy beaches of the coast. Although the gulf of Kotor is commonly referred to as a fjord, it was not formed by glacial movement and is in fact a ria (a drowned river canyon), but is by common consent, spectacular. Drive into the mountains to find undrowned river canyons (the Tara canyon being the second deepest in the world), glacial lakes, untouched nature and a fledgling ski and eco-tourism industry. On the coast, the climate is Mediterranean rising to 40 degrees in August, but cooler inland where the climate is Continental.

#### **Lake Skadar National Park**

When you go towards the sea from Podgorica Airport, you will find unexpectedly beautiful scenery. An expanse of turquoise water, covered with a carpet of waterlilies, interrupted by numerous islands... Welcome to the heart of Montenegro – Lake Skadar National Park! 222 km² of this remarkable ecosystem has been protected since 1983, and it has been on the Ramsar List of Wetlands of International Importance since 1995.

#### **Lovćen National Park**

Here you can find one of the top places you have to visit while you are in Montenegro – Njegoš's mausoleum. This monument, to which you have to climb up 461 steps, is at the same time the grave of the ruler, poet, and philosopher Petar II Petrović Njegoš.

#### **Durmitor National Park**


As you are getting closer to Žabljak, through gentle pastures, you will start to suspect that this is a special place. These 39,000 hectares of true, untouched beauty were declared a protected area in 1952, and is found on the UNESCO list of World Natural and Cultural Heritage. Besides the mountain giant Durmitor, the national park also covers the Tara, Draga, Sušica, and Komarnica Canyons, and Europe's most recently explored canyon – Nevidio.

# Biogradska Gora National Park

The smallest national park is tucked into part of Mount Bjelasica, on the right side of the River Tara. It was once the king's game reserve, which means that it has long enjoyed special treatment. Within the park is Lake Biograd, which formed when a glacier slid down Bjelasica, but of course the locals have their own version of the story.

# **Prokletije National Park**

The Austrian geologist Ami Boué called Prokletije "the alps in the south of Europe" and that moniker has stuck to the present day. The 20 inaccessible peaks of more than 2,500 metres above sea level scare even experienced mountaineers. On the other hands, there is the endearing Lake Hrid, which just exudes calm.




# **Travel Information**


We advise all delegations to travel on Thursday, September 23th, or before.

#### **Airport**

Podgorica Airport is located approximately 15 km from Hotel Voco. Directions are readily available on Google Maps.



Tivat Airport is located approximately 77 km from Hotel Voco. Directions are readily available on Google Maps.



#### **Shuttle Bus Service**

The federation will provide shuttle bus services between the competition venue and participants' hotels where possible. Further information will be provided closer to the event dates.

**Weather:** Days are usually hot with balmy evenings, so visitors should pack light and cool clothing. The average daily maximum is 27° C and the average daily minimum is 18° C.

Time: GMT+2.

**Electricity:** 220V. Montenegro uses a standard plug with two round pins.

charges you might incur.

**Visa:** Not necessary for citizens of any SSEKF member state.
